#### Tweetchat Rallies Around Gender Equality for International Women's Day

March 8 marked International Women's Day, and to commemorate this year, The Asia Foundation's Women's Empowerment team hosted a tweetchat relay using the hashtag #IWDchat16, titled Advancing Gender Equality in 2016 and Beyond. We partnered with six other organizations and projects – USAID, World Vision, Promundo, Chemonics, USAID ASSIST, and Knowledge for Health – to highlight the progress being made toward achieving gender equality, to discuss continuing challenges, and to focus greater attention on the importance of

empowering women and girls. With over 500 participants and over 2,100 tweets, the chat reached more than 4.1 million people representing activists and civil society as well as government, non-profit and private organizations, and more. The conversation covered diverse topics from how family planning can improve gender equality and using data to visualize gender gaps, to why including men and boys is essential and how empowering women is central to organizational effectiveness. During our half-hour segment, we posited to participants why gender equality is central to good governance through a series of five question and answers.
