
## **Upcoming Events**

## Mongolia's Amended Law Makes Domestic Violence a Criminal Offence

Last December, Mongolia's Parliament passed an amended version of the 2004 Law to Combat Domestic Violence. Recent amendments have made domestic violence a criminal offense for the first time in the country's history and mark a critical step forward for victims of this type of violence.

This is a particularly momentous step for Mongolian women, who, despite the country's relatively high score on gender equity measurements, experience high levels of domestic violence. The change demonstrates the government's commitment to combating domestic violence, protecting domestic violence victims, and holding perpetrators accountable. 
#### To Advance Afghanistan's Regional Role, Diplomats Need Language of International Relations

In December, delegates from nearly 40 countries attended the sixth annual Heart of Asia Ministerial Conference in Amritsar, India, to discuss peace, cooperation, and economic development in Afghanistan. Five such events have taken place since the first conference was held in Istanbul in 2011, and serve as a platform for regional cooperation by placing Afghanistan at its center. Addressing the key challenges facing Afghanistan, particularly the need for economic growth, job creation, and improving security, will require more effective and nuanced engagement beyond Afghanistan's borders. To tackle these issues, the Asia Foundation began an English-Language Training Program (ELTP) under the European Union-funded Promoting Regional Cooperation Capacity in the Ministry of Foreign Affairs (PRCC-MoFA) project which supported strengthening the institutional capacity of the Regional Cooperation Directorate (RCD) within MoFA. ## Survey on Access to Land, Tenure Security and Land Conflicts in Timor-Leste Houses

This study aimed to pilot an innovative land survey to provide quantitative data regarding land-related issues in Timor-Leste, in order to support the Timorese government and parliament in developing evidence-based land policies and legislation, as well as more informed advocacy of civil society. The results of this pilot in the municipalities of Dili (urban area only), Ainaro, and Ermera provides relevant evidence regarding access to land, land tenure security, and land-related conflict, as well as on the specific policy options taken in the current draft Land Law Package.



#### State and Region Financing, Planning and Budgeting in Myanmar

Effective subnational public financial management is essential if state and region governments are to achieve their potential in addressing local and national policy development priorities, including the delivery of public services in their areas of jurisdiction. This report provides a foundation for a better understanding of the current subnational public financial management in Myanmar. It presents an overview of the constitutional, institutional, and financing framework that determines subnational public expenditure. The report particularly focuses on assessing both how priorities and investments are determined in sectors that are now under the authority of state and region governments, and those which remain under direction from the Union level.
