- 2015 hta bai gram da ai upade hta lawm ai tinghkrai shang gumhpraw hte hpaga yumga galaw ai kaw na hta shinggyin la lu ai ahkun ni kaw na shang gumhpraw hte madung seng ai
- Mungdaw/Ginra Asuya ni a shang gumhpraw yawng ai 9% (2016-2017)
  - Mungdan kata kaw hpaga hku dut mari ai gunrai ni a ntsa hta ai ahkun kaw na shang gumhpraw a 15%







FY 2016/2017






