The Asia Foundation Supports APEC Digital Prosperity Award

The 2019 APEC App Challenge brought together 22 software developers and designers to design, build, and demo innovative mobile and web apps that have the potential to help women entrepreneurs grow their businesses in APEC economies. Launched in 2017 and supported by the <u>APEC Secretariat</u>, <u>Google</u>, and The Asia Foundation, the APEC Digital Prosperity Award recognizes initiatives that have the most potential to broaden prosperity and inclusive growth in the Asia-Pacific. The winners of the Award are two innovative programmers from Malaysia—Faezrah Rizalman and Jeanette Goon, who designed Bayu Harvest, an app to help small-scale women farmers sell their product on an e-commerce platform designed specifically for them. Afghanistan weighs peace talks with the Taliban as China's president Xi Jinping wrestles with environmental challenges, poverty reduction, and financial risks. Nepal's Transition to Federalism: A Behavioral Approach



The introduction of federalism and the decentralization of governance in Nepal were explicitly envisaged to improve services at the local level. Despite an abundance of political will and institutional buy-in pursuing reforms, the main objective seems elusive. To understand the ways that actors in a system of decentralized governance decide, or fail, to act, The Asia Foundation and <u>ideas42</u> have been developing a new toolkit using behavioral science to study governance, particularly the knotty challenges that have hindered reform and the transition to federalism in Nepal. Preliminary insights identify the underlying psychological phenomena of status quo bias, identity, social norms and the "planning fallacy" that require further exploration. Alternative Dispute Resolution Gains Traction in Pakistan

The Asia Foundation and the Kinnaird College for Women organized a seminar on *Mediation—A New Code of Adjudication* to explore the challenges, opportunities, and new developments in alternative dispute resolution (ADR) in the 21st century. ADR has been gaining policy traction in Pakistan since 2017 with the passage of several legislations in Islamabad, Punjab and Sindh. The Lahore High Court's (LHC's) strategic roadmap—*Vision: 2017*—prioritizes the training of ADR practitioners, which is also conducted under The Asia Foundation's project, *Mainstreaming ADR for Equitable Access to Justice in Pakistan*. 

Industrial Revolution 4.0 and the Future of Work: Implications for Asian Development Cooperation

Organized jointly by the KDI School of Public Policy and Management and The Asia Foundation, this year's "Asian Approaches to Development Cooperation" (AADC) dialogue series discussed how Asian development cooperation could factor in the features of industrial revolution 4.0 (4IR) and to address the challenges posed by the future of work. The discussion included exploring present structural readiness in respective national contexts for the changing technological landscape, examining new types of partnerships in preparing for the transition, reviewing private sector-led strategies in tackling these challenges, and identifying areas of region-wide cooperation for mutual competitiveness. Afghanistan in 2019: A Survey of the Afghan People



The longest-running barometer of Afghan opinion, the <u>Survey of the Afghan People</u> is a map of social change over time, presenting a clear picture of the gains and gaps that Afghans perceive in a rapidly transforming nation. The Survey, now on its fifteenth edition, has gathered the views of more than 129,000 Afghans since 2004 on security, elections, governance, the economy, essential services, corruption, youth issues, reconciliation with the Taliban, access to media, migration, the role of women, and political participation.
